Dear Director Wray:

As you know, it was recently reported that Representative Eric Swalwell (D-CA-15) had a personal relationship with a suspected Chinese spy, Fang Fang or Christine Fang. The interactions between Rep. Swalwell and Ms. Fang date back to 2012 and include many troubling ties between the two individuals. To the concern of many Americans, Rep. Swalwell serves on the House Intelligence Committee, a committee that is privy to some of our nation's top secrets.

It has also been reported that Rep. Swalwell was briefed by intelligence officials in 2015 about suspected Chinese spies trying to infiltrate Congress. Shortly after this briefing, Ms. Fang fled the country.

I write to inquire on a number of concerns related to this matter and to request a classified briefing from the FBI for all Members of Congress.

- Is the FBI currently investigating, or have they ever investigated, Rep. Swalwell and his relationship with Ms. Fang?
- Is there any link between Rep. Swalwell's briefing and Ms. Fang's fleeing the country? Could he have possibly tipped her off?
- Was a significant counterintelligence opportunity lost when Ms. Fang fled the country?
- Was there any opportunity for Rep. Swalwell to turn Ms. Fang and use her for counterintelligence?

Thank you in advance for your timely reply. We look forward to scheduling a classified briefing.
