A BILL

To amend the Omnibus Crime Control and Safe Streets Act to include reporting requirements of felony convictions related to animal cruelty, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Law Enforcement Ani-
5 mal Safety and Harm Reporting Act of 2026” or the
6 “LEASH Act of 2026”.

1 **SEC. 2. ANIMAL WELFARE DATA REPORTING.**

2 (a) BYRNE JUSTICE ASSISTANCE GRANT ELIGI-
3 BILITY.—The Omnibus Crime Control and Safe Streets
4 Act (34 U.S.C. 10153 et seq.) is amended—

5 (1) in section 502(a), by adding at the end the
6 following:

7 “(7) A certification that, for each fiscal year
8 covered by an application, the applicant will report
9 to the Attorney General data on felony convictions
10 under State law that involved cruelty to animals in-
11 cluding the name of any individual convicted under
12 such law.”; and

13 (2) in section 505(f), by striking “to those ju-
14 risdictions with the highest annual number of part
15 1 violent crimes of the Uniform Crime Reports re-
16 ported by the unit of local government to the Fed-
17 eral Bureau of Investigation for the three most re-
18 cent calendar years for which such data are avail-
19 able” inserting “to units of local government—

20 “(1) with the highest annual number of part 1
21 violent crimes of the Uniform Crime Reports re-
22 ported by the unit of local government to the Fed-
23 eral Bureau of Investigation for the three most re-
24 cent calendar years for which such data are avail-
25 able; and

1 “(2) that submit data to the National Incident-
2 Based Reporting System on felony convictions under
3 State law that involved cruelty to animals including
4 the name of any individual convicted under such
5 law.”.

6 (b) DEPARTMENT OF JUSTICE DATABASE.—Not
7 later than 2 years after the date of enactment of this Act,
8 the Attorney General shall—

9 (1) establish a publicly accessible database con-
10 taining the data reported under section 502(a)(7) of
11 the Omnibus Crime Control and Safe Streets Act
12 (34 U.S.C. 10153); and

13 (2) periodically update such database.

14 (c) EFFECTIVE DATE.—The amendments made by
15 subsection (a), shall apply to applications for grants sub-
16 mitted during the first fiscal year that begins after the
17 date that is 2 years after the date of enactment of this
18 Act.
